North State Bridal Showcase (Producer) and Exhibitor	agree as follows:						
Producer is not responsible for notifying the exhibitor of other participating exhibitors within the same category. Producer agrees to stage a bridal show at the location and on the date listed as listed on Page 1 of this contract from 1:00 pm to 4:30 pm. Th following terms and conditions apply to each bridal show. Requested booth locations are not guaranteed. Exhibitor agrees that his booth is not transferable without approval. Producer may use his best judgment in promoting and staging this event. Producer may, at his sole discretion determine if any display or conduct in Exhibitor's booth is offensive to attendees. If, upon notice to correct said display or conduct, Exhibitor has more than the provided number of tables in Exhibitor's booth, Exhibitor agrees to pay the decorating company for them, unless they belon to Exhibitor. Exhibitor agrees not to use other exhibitors' tables without written authorization from Producer. Event program listings will not be provided for exhibitors signing up after one month prior to show date. Producer may for any reason change the date, times, and place of the show by giving Exhibitor ten days' notice before the show. Producer may change the floor plan or booth assignments without notice. Exhibitor releases Producer of any liability for damage to or theft of any of Exhibitor's personal effects, display, product, or materials, even if moved be Producer's personnel or contractors. Business listing in event program uses Company Name as shown on the Exhibitor Booth Contract. Produce may shorten name to fit. Producer does not guarantee an exclusive to any exhibitor for any product, service, or category, unless provided i writing. All food and beverage items and sampling sizes must be approved in writing by the Producer no later than 30 days prior to the show and pay applicable fees. Cooking demonstrations are not allowed. Exhibitor empties own booth trash. Exhibitor agrees not to distribute at the show any literature, business cards, or other information for the benefit of any

If Exhibitor's assigned booth is empty at 12:01 pm on the date of the show, Exhibitor agrees to not begin removing his exhibit until the advertised closing time 4:00 preceive a list of brides.
